The meeting was called to order at 10:00 A.M.

1. Accepted the minutes from the Phoenix meeting.
2. Craig Robinson gave the Board of Directors Report to the Committee.
 - a. The Committee discussed the NABC Schedule passed by the Board.
 - The Committee was asked to consider drop-ins from the Spingold to the North American Swiss.
 - The Committee discussed a seven-day team game at the Fall NABC following the Blue Ribbon Pairs.
 - The Committee discussed having 2-day 10K events starting on the second day of the 3 day team events.
 - The Committee strongly favored suggesting that a 3 day pair event followed by a 7 day team event should be the base-line schedule for the Fall NABC.

- The Committee discussed the creation of a 3-day Swiss at the end of the 7 day team game at the Fall NABC.
- b. Due to the complexities of the scheduling at NABCs, a sub-committee was formed to further explore the above issues. This sub-committee comprised:

 - Jade Barrett
 - Jeff Meckstroth
 - Jeff Ford
 - Chris Compton
- 3. Adding 2D showing an unknown major suit as a defense over NT to the GCC (e.g. Woolsey) was discussed by the Committee. The Committee was strongly in favor of this as a motion.
- 4. The Committee discussed a project involving Lynn Johannson, a technical writer, who has volunteered to work on a “Blue Book” style description of Standard American Yellow Card. Will Ehlers volunteered to be a liaison to Johannson from C&C. Linda Trent volunteered to proofread the manuscript.
- 5. The Committee discussed the possibility of creating a new chart between the Mid-chart and the Super Chart.
- 6. The issue of “knock-off” convention cards not reviewed and approved by the ACBL was discussed.
- 7. The Committee tabled the issue of the feasibility of forcing sponsors to use specified convention charts.
- 8. There was a wide-ranging discussion of cue bids and doubles, including expanding the definition of a cue bid and whether or not doubles showing specific strength or distributions should be alerted (i.e. a double showing a specific statement about a specific suit).
- 9. The Committee discussed the suggested defenses to Mid-chart possibly being out-of-date. The defenses should be reviewed on a regular basis.
- 10. There was a discussion of the appeals process and whether or not adopting the “European-method” of appeals (i.e. appeals made to a team of directors) was a good option for the ACBL. This item is to be included on the agenda for Las Vegas.
- 11. The idea of playing the same boards in the IMP Pairs and the regional pairs was met with a negative response from the Committee.
