#### Zeller, Bright are IMP Pairs champs

Bob Zeller and Greg Bright entered the Lebhar IMP Pairs as a first-time partnership, but the duo convincingly won the four-session contest, giving each of them their first NABC title.

Zeller, of Ottawa ON, and Bright, of Westminster MD, scored 113.77 IMPs in the event, while second place went to Leo Weniger of Halifax NS and Ronald Mak of Manchester NH with 79.41 IMPs.

"We got a lot of gifts," said Zeller, who

### Vanderbilt: Round of 64

Yesterday's opening round in the Vanderbilt Knockout Teams reduced the field of 68 entrants to 64 for today's head-to-head matches. Fifty-four squads received byes yesterday, while a series of four-way and two-way matches determined which of the remaining 14 teams would survive to today.

### 10K Knockouts in QF round

Thirty-one teams entered the 0-10,000 Knockout Teams, and yesterday's matches reduced the field to 16 teams for head-to-head matches, and then whittled it further to eight squads for today's action.

### Three enter Hall of Fame

Three great players have been elected to the ACBL Hall of Fame: Peter Boyd, Bart Bramley

To be eligible for this honor, they must be North American residents at least 60 years old who have achieved prominence in the game and have an outstanding tournament record. The Hall of Fame Committee nominates candidates, and a pool of electors votes on them.

#### **Peter Boyd**

Boyd, 68, is a former systems analyst/ programmer and bridge professional. His 17 North American titles include three Vanderbilts and a Reisinger. He won a gold medal in the 1986 World Open Teams, his first time playing in a world championship, and a silver in the 2011 d'Orsi Senior Teams.

Although his parents did not play bridge, he learned young – from a different family. "One of my best friends from grade school was an only child," Boyd explains. "His parents wanted to teach their son to play bridge, and they needed a fourth. I learned to play at their kitchen table."

He managed to find a Goren book around his house – even families who didn't play might have one of those – and read up to learn more.

Boyd began working as a programmer after college and continued until 1995. He lives in Darnestown MD with wife Ellen Klosson and five Afghan hound show dogs.

Since 1980, Boyd has played with Steve Robinson, a Hall of Famer and the dean of the DC-area bridge scene. They have played in more

#### **Mark Sorenson**

Players in the area of San Mateo Unit 498 know Sorenson as someone who's always willing to help. He started out doing things for his club and unit, such as setting up and tearing down for games. Then he got into mentoring newer players, taking it to the next level by creating memory aids for them.

They found out how far he was willing to go to help someone when one of their members was incapacitated by a long-term illness. Sorenson knew Nancy Gordon from their time together on the unit board, when she trained him on food planning for sectionals and unit games. Gordon, who was living with chronic obstructive pulmonary disease, lived by herself and didn't have any family. As her condition worsened, Sorenson began taking her to appointments and running errands for her during the summer of

#### **Monitoring**



These recordings are also be uploaded to the internet following the NABC.

By general monitoring of the session and participants' behavior, ACBL has another source of information that may be useful in determining facts and settling issues or disputes arising from some types of ethical and behavioral complaints or actions. Please summon a director if a problem occurs at the table. This procedure is intended to assure everyone that the playing field is level and that misbehavior will not be tolerated."

A touchy grand slam: 7♦ is your contract, and the opening lead is the ♣K. Plan your Grand Slam play.

You have a possible heart loser, a loser that can be avoided if East has the ♥O. On the other hand, if West has the ♠J, you can lead a spade to the 10. If the 10 holds you can discard two hearts from dummy on the AK Q. No more heart loser. In other words, you are looking at two finesses, and if either works, you can make your grand slam – but if you take the wrong one, down you go. If only you knew which one to

Tip: When either of two finesses will give you your contract, one suit missing a queen,

the other a jack, play the A-K of the suit missing the queen (hearts, in this case). If the queen doesn't appear, take a finesse in the suit missing the jack (spades). Because one finesse is as good as the other, you pick up close to an extra 20% by cashing

the ♥A K before taking the spade finesse, as the ♥Q might fall under the A-K. Testing hearts without giving up the lead has kept you alive to take the spade finesse, not to mention that extra 20%.

Notice that if you had the ♠K Q 9 4 instead of the ♠K Q 6 4, the ♠J would drop under the A-K-Q almost 37% of the time allowing you to discard two hearts on winning spades and avoid the heart finesse. Alternatively, if you play the ♥A



K first, you will drop the queen close to 20% of the time and avoid a future finesse that way. So if you are lucky enough to have two possible lines that might help you avoid a future finesse, take the one that offers the best percentage chance. Translation: Spades before hearts with the ♠9, hearts before spades without it.

#### Appealing a ruling

Players in NABC+ events who want to appeal a director's ruling initiate the process by speaking with the director who delivered the original ruling. The table director will fill out paperwork regarding the appeal, and the appellants will explain what they believe to be wrong with the initial ruling. From there, the case may be handled by a variety of means. When the appeals reviewer receives the case, the circumstances of that particular case will determine whether the case can be resolved by the original staff (in the case of misapplication of Law or regulation, for instance), a panel of directors, or even a committee-type hearing which could include bridge experts.

#### **Notice of binding** arbitration

By becoming an ACBL member or renewing your membership in the ACBL, you expressly agree to waive your right to have disputes between you and the ACBL resolved in a court of law and agree to accept the use of binding arbitration before the American Arbitration Association. 

than 100 NABCs since then, missing only two, and they also play in local tournaments.

"Whenever I want to rant about something, I talk it over with him and he tells me why I should be more reasonable," Robinson said. "He is very easy to play with and very rarely forgets our agreements, which can be complicated."

Another top player in the DC area, Beth Palmer finds much to praise in Boyd. "Peter is obviously an excellent bridge player and makes very few technical mistakes. Even more important, he is always a very pleasant partner, teammate and opponent. He is the rare bridge player who is nice not only when he is winning but also when he is losing.

"As a teammate, I can say that when a mistake is made, his first reaction is that his partner or teammate did what was right and was unlucky to have a bad result. ... He also has set an example for honesty in District 6, and by setting the tone that this is how bridge should be played, it has permeated to all levels of the district. ... He frequently plays in local sectionals, regionals and Grand National events and is always willing to talk about bridge to less experienced players."

His active participation in District 6 North American events has resulted in three wins each in the North American Pairs Flight A and the Grand National Teams Championship Flight.

In 2009 Boyd was honored with the Sidney H. Lazard Jr. Sportmasnship Award. He has served many terms on the boards of Unit 147 and District 6 and several other committees. He was recently elected chair of the Ethical Oversight Committee beginning in April.

Boyd names his Hall of Fame election, world championship and sportsmanship award as the most significant events of his bridge career. "I feel very honored to be elected to the Hall of Fame," he said. "I believe that several of the women players on the ballot deserve to be elected, and I think they will be in the coming years."

#### **Bart Bramley**

Bramley, 71, played in his first NABC in 1967 and hasn't missed one since 1982. Along the way he's won 17 titles – including a Vanderbilt, a Reisinger, two Blue Ribbon Pairs and a von Zedtwitz – and 14 second-place finishes. He has three world medals: gold in the 2007 d'Orsi Senior Teams, silver in the 2005 Transnational Open Teams and bronze in the 1998 Open Teams. He was the 1997 Player of the Year and placed


#### **Be Scent-sitive!**

Some people have an extreme sensitivity to fragrances (colognes or perfumes). Many ACBL clubs, units and districts have adopted policies that prohibit players from wearing fragrances. The ACBL has not issued an official policy on the matter, preferring instead to appeal to the goodwill of its members to refrain from using fragrances.

Because duplicate bridge requires players to be in close proximity to each other, individuals who suffer from fragrance-related reactions cannot avoid those who are wearing them. Among the commonly reported symptoms are intense headaches (indeed, fragrances can frequently be a trigger for migraine sufferers) or breathing-related problems. For these individuals, the issue is much more serious than simply disliking a particular smell — it's a real health problem.

The ACBL asks everyone to give this issue serious consideration. If you're going to play in a club or a tournament, please don't wear cologne, perfume or scented lotions.

second in the World Par Contest in 1998.

As a child in Connecticut, Bramley started learning bridge at 5 from his father, who died when Bart was 10. He attended the prestigious Choate School and began playing duplicate before starting MIT in 1966. There he met Ken Lebensold, a grad student and skilled player who shared his knowledge with fellow students, including Mark Feldman, Lou Reich and Chip Martel. Bramley considers Lebensold a key influence who helped his game take off.

Bramley worked for Boeing in Seattle and then as an options trader in Chicago before moving to Dallas to work as a risk management analyst. "I've had day jobs all my life, but they've all been to support my bridge habit," Bramley

Bramley recently retired as chair of the Ethical Oversight Committee after leading it through its most challenging cases that emerged from the 2015 cheating scandals. He has been with wife Judy for over 40 years. He's a big fan of baseball and classic rock.

Over 52 years Bramley has had several partners, including Lou Bluhm, Sidney Lazard, Lew Stansby, Bob Hamman and Kit Woolsey among others.

"Bart demonstrated an amazing versatility

with many partners over the years," said Bob Hamman. "He did well with practically anybody he ever played with. He's a tough competitor who has a real ability to concentrate on just about every hand. There's never an easy hand against Bart."

Hamman recalls the first time he played with Bramley, in the 1990 Jacoby Open Swiss in Fort Worth. They spent about a half hour going over a card, and their team won the event.

"I felt he got his due when he got into the Hall of Fame," Hamman said. "He's a class act."

Bramley was ecstatic to finally get elected on his 10th time on the ballot. "I'd heard no nine times before," Bramley said. "I didn't expect it to be different this time."

Bramley's favorite accomplishments are winning Player of the Year, his win in the 2002 Blue Ribbon Pairs with Sidney Lazard - his favorite partner of all time – and the Par Contest, where he won \$17,000 for placing second. He had made a strategic decision to use the maximum amount of time per problem, where errors were 100-point deductions and time cost a point per minute. Bramley solved all 12 problems exactly the same as eventual winner Michael Rosenberg but lost on time.

"It takes me a while to get there," Bramley said, explaining the time it took to get his first win in a sectional, regional and finally an NABC at 32. "Each step along the way took me a little longer than what I consider my peers."

#### Judi Radin

By the time Radin was 37 in 1994, she had four world championships and three silver medals – beginning with a gold in the Women's Pairs with Kathie Wei-Sender on Radin's first time at a world championship in 1978 – and has since added a bronze. In North American events, she has 16 wins and 17 seconds, including a

Growing up in Detroit, she began learning bridge at 7 when her family decided to take lessons together, the same year she started golf. By the time she was 17, she was a bridge professional with a scholarship to play golf at the University of Michigan. But she never arrived in Ann Arbor. When riots broke out there before her high school graduation, Radin's mother decided Michigan wasn't safe and forbid her from going. She had to scramble to find alternative college plans and managed to get into Barnard.

Moving to New York was a pivotal event. She had to give up golf because there weren't any golf courses in the city, but it was a great place to start a bridge career. Though she initially became a stockbroker after college, she quit because she was getting paid more to play bridge. Still in New York with husband Michael, she has also built a reputation as one of the best theater critics in the city.

Outside of competition, Radin has also maintained a successful teaching practice and, as founder and co-chair of the Arthur Loeb Cup, an annual pro-am event, she has helped raise \$500,000 for the Lenox Hill Neighborhood House.

"Judi is a natural," says Stacy Jacobs, a frequent partner. "A pro's pro. She is fierce competitor and a true champion. She plays fast, she sees situations, and she rarely makes mistakes.

"Bridge lives in Judi's brain in a way that it doesn't live in mine. ... I've seen her play flawless championship bridge through illness and injury, minor and major. Regardless of what is happening around her, Judi Radin can always, always play.'

At the 2013 Fall NABC in Phoenix, Jacobs was playing with Radin on the first day of the Women's Pairs. They were going over the hands that night when Radin fell ill. She was taken to the hospital and doctors determined she had suffered a stroke.

"She negotiated an early discharge from the hospital and was back in her chair playing her usual exemplary game when the board-a-match began 36 hours later," Jacobs notes.

Radin explains she fought her way out of the hospital because she didn't want to lose out on her fees for the events she was booked to play in. "I don't remember anything about playing that day, but my teammates said I played good."

In the five years since her stroke, Radin has added three second-place finishes in NABC events to her resume. But the substance of it, she says, has been in place for 25 years.

"I'm very excited," Radin says about her election to the Hall of Fame. "It takes a lot of stress out of your life waiting all that time. I'm thrilled. All this wait, all this time, it's still great to get in."



### Convention card reminder

Each player is required to have a convention card filled out legibly and on the table throughout a session. The convention card must include the first and last name of each member of the partnership, and the cards must be identical.

If a director determines that neither player has a substantially completed card, the partnership may play only the Standard American Yellow Card and may use only standard carding. This restriction may be lifted only at the beginning of a subsequent round after convention cards have been properly prepared and approved by the director. Further, the partnership will receive a 1/6-board matchpoint penalty for each board played, commencing with the next round and continuing until the restriction is lifted. In IMP team games, penalties shall be at the discretion of the director.

If the director determines the partnership has at least one substantially completed convention card but has not fully complied with ACBL regulations, the director may give warnings or assign such penalties as he deems to be appropriate under the circumstances.

The objective of these warnings and penalties is the encouragement of full compliance with ACBL regulations.

2016. Soon she had live-in hospice, but she was unhappy with the food they supplied.

For 10 months, Sorenson drove a half hour each way from San Bruno to Foster City to take Gordon meals at least three times a week. He continued to do chores and other errands for her until she died in June 2017.

"I just did it," Sorenson says. "I enjoy cooking for my family. When Nancy could use my help, I started bringing things and found out what she enjoyed."

An amateur chef, he kept a list of her favorite dishes, which ran more than 40 items long.

"I just built it into my daily routine," he says.

"A lot of the time, I would make something for my family and bring her the leftovers the next day."

Since Gordon's death, Sorenson has remained active in mentoring. About 12 times a month he plays with either a mentee or someone who doesn't have a partner. After their games, Sorenson emails his partners analyses of particular hands or one of a dozen "cheat sheets" he's created to help them learn various conventions.

"I try to be the kind of mentor my mentees would like to have," he said.

#### **Shawn Stringer**

District 6 Director Margot Hennings describes Stringer as the hardest-working person she knows. "In the tradition of Nadine Wood, she does everything, including the jobs no one else wants to do."

Among those jobs was refurbishing the metal boards District 6 uses at its regionals: removing the old felt, boiling the boards, scraping off the residual glue, attaching new custom-made strips

of self-sticking felt and repainting the vulnerability indicators. She also washed all of the district's bidding boxes in her dishwasher during the summer of 2016.

"I'm a little OCD when it comes to equipment," Stringer said. "I hate dirty bid boxes, or boards where you

can't read the number. District 6's metal boards are about the same age as most of our members. But they're looking pretty good."

As the district's regional manager since 2015, Stringer is responsible for making sure all of the necessary equipment is on site for district events. She was also district president for three years until September 2018, chaired several regionals during that time and is president of the Mid-Atlantic Bridge Conference. She has been tournament chair for the Chesapeake Regional since 2012 and also previously ran the Bethesda Regional, a job she got corralled into doing upon the 2011 death of Wood, the person her award is named for.

"Nature abhors a vacuum," Stringer says.
"When I see something that needs to be done, I think, 'I can do this.' It's pride. I started a job and I don't want to quit."

Another factor that earned Stringer the award is her efforts to recruit and train other volunteers, especially those who have taken over as tournament chairs for District 6 regionals. "She not only is a volunteer, but she takes it upon herself to mentor and train volunteers," Hennings said. "There are a lot of people volunteering who are attributable to her."

In order to train more volunteers in maintenance of metal boards, Stringer joked she plans to offer a seminar called "Learn Glue in a Day."

#### **Chuck Wilkinson**

As representative of the district where the Spring NABC is being held, ACBL President Russ Jones presented a special award to Chuck Wilkinson of Jackson MS, who could not be present.

Wilkinson served many years as a unit president, district president and on the ACBL

Take this deal from the final of the Platinum Pairs reported by John Hurd (deal rotated):



As declarer, you win the club lead in dummy and have to decide how to play trumps. At the table, declarer Hurd led a low heart from the board and took the queen with the king then ran the \(\psi\_8\). This was the full deal:



When Kevin Rosenberg scored the 9, he not only had a brilliancy prize entry, but the admiration of his opponents, Hurd and Jeff Meckstroth, and partner David Gold!

### NABC Electronic Device Policy

Except by
permission of the
director in charge, any
electronic equipment
or device capable
of receiving or
sending an electronic
signal, or capable of
communicating in
any way, may not be



operated or functioning in any manner in the playing area during a session of play. Any such equipment must not be visible during the session and must remain off at all times.

The above restrictions apply to all players, captains, coaches, kibitzers and play recorders except those persons granted permission by the ACBL, and are in force throughout any playing session or segment of play. Further restrictions and requirements apply in events involving live internet and/or yugraph coverage.

A violation of any of the above restrictions will result in an automatic penalty, pursuant to Law 91 of the Laws of Duplicate Bridge.

#### **NABC+** events

- First offense of any kind (ringing, answering or initiating a call, texting or browsing) in a session: One full board, 12 IMPs or 20% of the maximum available VPs per match, at the respective form of scoring.
- Second offense in the same session or third offense within the event, disqualification of the pair or team from the event.

#### Other events

- First offense, in the same session ringing only: one-quarter board, 3 IMPs or 1 VP, at the respective form of scoring; first offense in the same session answering or initiating a call, texting or browsing: one-half board, 6 IMPs or 2 VPs, at the respective form of scoring.
- Second offense in the same session: two full boards, 20 IMPs or 50% of the maximum available VPs per match, at the respective form of scoring.
- Third offense in the event: disqualification of the pair or team from the event.

Kibitzers violating this policy will be removed from the playing area for the remainder of the session

This policy applies to all events at NABCs.

proceeded to give the example of their very first board in the evening session of the final.

"We bid to a nonvulnerable 4♥, but our opponents took a vulnerable sacrifice in 4♠ and went for 1400. Not a bad start."

Bright agreed: "Lots of things went our way." The winners, who qualified in 57th place, moved to 12th after the first final session before clinching the win in the second final.

Stretching the truth

Bridge has its own social media platform

– BridgeWinners. This is a private venture, not sponsored by ACBL or any bridge organization. I find it interesting and educational. There are a wide number of topics discussed on the Bridge Winners site, including a series of articles by Kit Woolsey, a lot of news from around the world of bridge, and unfortunately, a fair amount of gossip.

There were two articles recently that were of interest to me as a recorder. The first was titled "10-19 Notrump."

For the entire history of contract bridge, in all its forms, there have been "asymmetrical" partnerships – where one player has significantly more experience and/or skill than the other. Sometimes this involves two people in a relationship or friendship, sometimes it is a teacher playing with a student, and sometimes it is a sponsor playing with a pro.

Law 72A states "Duplicate bridge tournaments should be played in strict accordance with the Laws. The chief object is to obtain a higher score than other contestants whilst complying with the lawful procedures and ethical

standards set out in these laws."

In the quest for a "higher score," players will sometimes take actions that aren't normal, and this is OK if it is done legally. For example, it is not unreasonable for the better player to sometimes prefer to play notrump from their side rather than to allow partner to play the theoretically better major-suit contract.

When does such manipulation cross the line into illegality?

Because of the high probability of becoming declarer when one opens the bidding with a natural notrump bid, the better players are tempted to stretch the definition of their notrump agreements to the extent of stretching the range a point, or two or three. There is also temptation to bid notrump with unusual distributions including hands with low singletons.

In the ACBL, current regulation does not permit an opening 1NT range of more than 5 HCP. Also, you are not allowed to have an agreement to open 1NT with fewer than 10 HCP (you are allowed to miscount, but you need to be convincing!), nor with a low singleton.

These rules have become strict. If you play 15-17 notrump openings, and you decide to upgrade your nice 14 HCP hand occasionally, that's OK. But if you play 13–17, you are already at the maximum permitted range. If you upgrade a 12 HCP hand or downgrade an 18 HCP hand, you may be subject to penalty and/or a score adjustment.

While these rules apply to 1NT opening bids, they don't apply to overcalls or higher notrump opening bids. However, when you do things like this, or psych in certain situations on a regular basis with the same partner, you have created an undisclosed partnership agreement which is against the rules and could get you disciplined. This is true whether or not you have ever discussed it. Just because you never discussed it, you can't assume, nor can you prove, that partner hasn't taken these habits into account when deciding what to do.

The second post that caught my eye involved a situation where the "pro" held:

**♦**Q 10 x x ♥x x x ♦x x **♣**A K Q x.

Partner opened 1♠, and the pro decided to respond 1♥ (natural) for some reason. Partner jumped to 3♥, and now the pro bid 3NT. Partner, holding a nice hand with a low singleton club, passed rather than going back to 4♥! That suggests an agreement or understanding from past experience in which partner knows to let the pro play 3NT. This is illegal. You can't even get away with it by Alerting, because then it becomes a "psychic control," which is not permitted.





#### Convention Center Access and Parking

Access to the second level is limited due to construction happening on the ground level of the Convention Center.

The escalators that travel between P1 (South Hall Lobby) and the East Concourse are inaccessible. Two of the South elevators will be available at all times to take passengers to all parking levels and Level 2.

South Hall and the parking level (P1) is under construction, and the West entrance ramp is closed. Parking is still available on the levels



below (P2 - Green and P3 - Orange). Vehicles taller than 6'1", which cannot access the P2 or P3 parking, may park in the Front Street parking lot north of the garage entrance.

To access the garage, enter the East entrance ramp off of Front Street and continue down the spiral ramp to P2 or P3.

The Convention Center staff has designated alternate entrances where you can access the closest elevators or escalators to reach your desired level.

To access the Second Level (Ballrooms, Exhibit Hall, Meeting Rooms 201-205):

From parking levels P2 and P3, ride an elevator up to level 2 (press '2' in the elevator).

From Main Street:

Option 1: Ride the escalator up to level 2.

Option 2: Enter the ADA entrance from the corner of Front Street and Poplar Avenue (adjacent to large metal sculpture). Ride the elevator to level 2 (press '2' in the elevator).

Option 3: Enter the Cannon Center lobby, head towards the west elevator, and ride the elevator to the Mezzanine level (press '2' in the elevator). ### Smokers: Stay away from the doors

Smokers – you know who you are – if you go outside to smoke, stay 50 ft. away from the entrance. It's the state law. And it's the nice thing to do. And no one wants to smell smoke inside the building. Really. Step. Away. From. The. Doors. Don't make us get all disciplinary ...









#### Slow play

Slow play, especially habitual slow play, is a violation of law and subject to penalty. When a pair has fallen behind, it is incumbent on them to make up the time lost as quickly as possible whether at fault or not. All players are expected to make a concerted effort to catch up when they have fallen behind, regardless of the reason for their lateness.

In the absence of compelling evidence to the contrary, the director should presume that a pair finishing a round late by more than two or three minutes on more than one occasion during a session is responsible for the lateness. There is a strong expectation that the director will penalize such a pair. The size of a penalty will tend to increase for subsequent instances of slow play and for chronic or egregious slow play.

While warnings typically will be given before a penalty is assessed, failure to do so in no way limits the director's authority to issue a penalty.

Players are expected to be aware, in a general sense, of time used and remaining in a segment in which they are playing regardless of whether a clock is in use or a time announcement has been made. An excuse of "no announcement" or "no clock immediately visible" will not be considered persuasive.

In consultation with the DIC of the tournament, the TD may require that a particular pair not play in a specified segment, not play against a specified pair or not play together as a pair. The foregoing is expected to be applied only due to egregious circumstances or to unduly repetitious offenders.

An appeal of an action taken by a TD with regard to time may be taken to the Director in Charge of the tournament, and no further. For NABC+ KO events, the TD is charged with the responsibility to ensure that each KO match segment finishes within the allotted time. While a time monitor may be employed, the lack of a monitor in no way limits the TD's authority to apply one or more of the remedies listed below.

The TD may choose to ignore an occasional minor late finish. The TD may remove one or more boards from a segment. The TD may award no score (when neither team is more at fault), an assigned score (when a result already exists at one table which the TD wishes to preserve) or an artificial score in IMPs. Every effort should be made to remove boards before they can be played at either table, but not having done so does not preclude removing one or more later.





### Henry Francis By Paul Linxwiler

For an entire generation of players, Henry Francis was the Bridge Bulletin. A 25-year editor at the Boston Herald Traveler and an experienced player and director, Francis was the perfect choice as captain of the magazine when the League moved from the East Coast to Memphis in 1972, and his flair for the job made him popular with players across the world. During his 25-year tenure as executive editor, Francis relished playing the role as the king of bridge press, and it was this persona that charmed legions of fans.

In addition to being at the helm of the Bridge Bulletin magazine, Francis edited Daily Bulletins at the North American and world championships for three decades. His experience as a newspaper editor made him adept at handling the tight deadlines and long hours required for producing those publications. Francis was also editor-in-chief for three editions of the Official Encyclopedia of Bridge, the massive compendium



of bridge history, trivia, biographies and records.

The ACBL twice presented Francis with its top accolades for his long and distinguished service.

In 1998, Francis was named the ACBL Honorary Member

of the Year. And in 2003, Francis was inducted into the ACBL Hall of Fame as winner of the Blackwood Award.

At his Hall of Fame induction in 2003, Francis shared several stories, including this one about his introduction to top-level directing that was sparked by an unfortunate incident at a club game in Boston.

"I was called to the table to make a mundane ruling about a revoke. The man and woman against whom I made the ruling protested, so I repeated the ruling ... straight out of the rule book.

"The next day, I learned that the husband had suffered a heart attack and died. The woman, who was understandably upset, blamed me for his death, and even went so far as to file charges. Nothing ever came of the charges, of course, but soon afterwards, I was invited to become part of the directing staff of the Eastern States Regional with the great Harry Goldwater. Goldwater (notorious for some of his quips) had asked me to come because he wanted the guy who 'can kill people with his rulings.""

Francis said that Goldwater immediately assigned him to the floor of the tournament and instructed Francis to pull no punches.

"I want five appeals tonight!" said Goldwater. Francis complied. "I had six," he said, proudly.
